## OCTOBER 2020 BAR EXAMINATION

The Supreme Court of Florida has released the following bar examination statistical information developed by the Florida Board of Bar Examiners. These results apply to the October 2020 Bar Examination administered remotely on October 13, 2020. This datum applies to only those persons sitting for the examination in Florida for the first time.
