APPLICATION FEE WORKSHEET

This worksheet is provided as an aid, only. For specific details, refer to the Rules of the Supreme Court Relating to Admissions to the Bar, Rules 2-20 and 4-43, and to the Rules Regulating the Florida Bar, Rule 11-1.3.

1. ATTORNEYS – If you have ever been admitted to practice law in any jurisdiction, choose the applicable category from the following list, enter the corresponding fee in line 1, and proceed to item 5. If this category is not applicable, enter \$0 in line 1.

Admitted less than 12 months.....	\$ 1,000	
Admitted more than 1 year, but less than 5 years.....	\$ 1,600	
Admitted more than 5 years, but less than 10 years.....	\$ 2,000	
Admitted more than 10 years, but less than 15 years.....	\$ 2,400	
Admitted more than 15 years.....	\$ 3,000	
Eligible to apply after disbarment or resignation pending disciplinary proceedings, regardless of length of time admitted.....	\$ 6,000	1. _____

2. LAW SCHOOL GRADUATES – If you are a law school graduate and have not been admitted to another jurisdiction, choose the applicable category from the following list, enter the corresponding fee in line 2, and proceed to item 5. If this category is not applicable, enter \$0 in line 2.

Filing a Bar Application in Florida for the first time.....	\$ 1,000	2. _____

3. LAW STUDENTS – If you are a law school student, choose the applicable category, enter the corresponding fee in line 3, and proceed to item 5. If this category is not applicable, enter \$0 in line 3.

For Student Registration (provides both CLI clearance and pursues bar admission):

Students who commence the study of law in August or September and file:		
by the following January 15.....	\$ 100	
by the following March 15.....	\$ 350	
after the following March 15, but more than 12 months from graduation.....	\$ 400	
Students who commence the study of law in January or February and file:		
by the following June 15.....	\$ 100	
by the following August 15.....	\$ 350	
after the following August 15, but more than 12 months from graduation.....	\$ 400	
Students who commence the study of law in May or June and file:		
by the following October 15.....	\$ 100	
by the following December 15.....	\$ 350	
after the following December 15, but more than 12 months from graduation..	\$ 400	
Students who are less than 12 months from graduation, and who:		
previously filed a student registration in Florida, and are now converting.....	\$ 600	
did not previously file a student registration in Florida.....	\$ 1,000

3. **LAW STUDENTS** – (continued)

For Certified Legal Internship (provides CLI clearance only* – does not pursue admission):

Within 250 days of beginning law school.....	\$ 75	
More than 250 days from beginning law school, and more than 12 months from graduation.....	\$ 150	3. _____

*Persons filing a CLI registration, who later change their minds and decide to pursue admission to The Florida Bar, will be required to pay the full \$1,000 application fee less the \$75 or \$150 CLI registration fee previously paid.

4. **MILITARY SPOUSE** – If you are submitting an application under the Rules Regulating The Florida Bar for authorization to practice law in Florida as a military spouse while your spouse is stationed within Florida, enter the corresponding fee in line 4, and proceed to item 7. If this category is not applicable, enter \$0 in line 4.

5. **EXAMINATION LATE FEES** – If you are applying now to take the General Bar Examination for the first time, choose the applicable category, enter the corresponding fee in line 5, and proceed to item 6. If you are not applying to take the General Bar Examination at this time (applies to law student registrants and CLI registrants only), enter \$0 in lines 5 and 6, and proceed to item 7.

February Examination

Postmarked or received on or before November 15.....	\$ 0	
Postmarked or received on or before December 15.....	\$ 325	
Received on or before January 15.....	\$ 625	

July Examination

Postmarked or received on or before May 1.....	\$ 0

6. **LAPTOP FEE** – If you have elected to use your laptop computer on the essay portion of the General Bar Examination, the laptop fee is due when you submit your application to take the General Bar Examination.

7. **TOTAL FEE DUE** – Add lines 1 through 6, and enter the total in line 7. Remit the amount entered on line 7 with your Bar Application. The board accepts [electronic payment](#) of fees by ACH or eChecks through Xpress-pay. When using Xpress-pay, if you owe more than one type of fee (for example, application fee plus laptop fee), after selecting the first payment type and adding it to your cart, you should click the “Find more bills” button to select additional fees as required rather than creating separate transactions.

Alternatively, you may make your check or money order (in U.S. dollars) payable to the Florida Board of Bar Examiners. The Board does not accept payment by credit card.
